The goal of the program is to create sustainable food systems that promote good health, vibrant communities, environmental stewardship, worker justice and accessibility for all. Fellow s come from many disciplines- chefs, farmers, nutritionists, activists, public health professionals, fishers, policy experts and academics. In 2010 the program had nine fellow s and started the process of recruiting applicants for the 2011 class of fellow s. The program also increased the participation of its 63 alumni by inviting the alumni to participate in online trainings and in-person gatherings. The fellow s worked on a wide range of issues from a campaign for fair wages for farm workers in Florida to healthier school lunches to facilitating better financing opportunities for sustainable food businesses. The program provided workshops for fellow s, and hosted gatherings on sustainable food for policymakers, foundation staff, journalists and others.
