# OVERUSE OF ANTIBIOTICS ON THE FARM AND THE EFFECT ON HUMAN HEALTH HIGHLIGHT INFORMATIONAL BRIEFINGS IN SENATE, HOUSE

#### SENATE BRIEFING AT 11:30, HOUSE BRIEFING AT 2:30

Medical health professionals, public health experts and the scientific community are increasingly concerned that the routine use of human antibiotics in the food and water of food animals results in antibiotic-resistant diseases in humans that cause extended hospital stays and increase health care costs. Experts agree that antibiotic resistance is a public health crisis that will only worsen if we don't act now. Panelists at the briefing will discuss the alarming increase in human antibiotic-resistant infections and review the state of the science linking this phenomenon to on-farm non-therapeutic antibiotic use. They will discuss the presence of antibiotic-resistant foodborne pathogens in retail meat, and the emergence of a new strain of methicillin-resistant *Staphylococcus aureus* (MRSA) in both humans and hogs which poses risks to U.S. hog farmers, their communities, and the public at-large. The panel will also discuss potential trade implications for U.S. farmers associated with antibiotic use.
